Terms and Conditions

PAYMENT AND COLLECTION: Payment is due within 30 days from date of invoice. Credit privileges may be unilaterally terminated by Guided Supply, LLC ("Guided") on delinquent accounts. The Customer hereby represents that it is, and will continue to be, financially able to meet any commitments it has made or may make. If, in Guided's sole discretion, the financial responsibility of the Customer becomes unsatisfactory, Guided may demand advance payments and may withhold shipments until receipt. In the event the Customer fails to pay any amount when due and if this account is referred to a collection agency or attorney for collection or legal action, the Customer agrees to pay an additional charge equal to the cost of collection including agency or attorneys' fees and expenses and court costs incurred by Guided in exercising its rights hereunder. All accounts shall accrue interest at 1.5% per month, from the due date of the invoice until paid.

DELIVERY, TITLE, AND RISK OF LOSS: The customer shall allow Guided a reasonable period for delivery of shipment of goods. Title to goods and risk of loss shall pass to the customer upon delivery to a carrier or into the Customer's transport. Guided may select the carrier and routing of the shipment.

INSPECTION AND LIMITATION OF LIABILITY: Notwithstanding the above and regardless of the circumstances, Guided's total liability to the Customer for any and all claims, losses, or damages arising out of any cause whatsoever, whether based in contract, negligence or other tort, strict liability, breach of warranty or otherwise, shall in no event exceed the purchase price of the goods from which such cause arose. In no event shall Guided be liable for special, incidental, punitive, consequential, or exemplary damages.

ENTIRE AGREEMENT: This Credit Application is the complete and exclusive agreement between the parties and supersedes any prior contracts or agreements, written or oral. No modification of this Credit Application shall be effective unless it is in writing and signed by both parties. No waiver of any breach of any term or condition of this Credit Application shall be construed as a waiver of any succeeding breach. This Credit Application shall be governed by the laws of the State of Indiana. Suit brought by either party arising out of or relating to this agreement shall only be brought in court located in Hamilton County, Indiana.
